



RENTAL POLICIES & AGREEMENT

RENTAL - A

- I. Your rented vehicle is a property of Fox Rent a Car / Economy Rent a Car a franchisee of KK and T Auto Rentals Ltd.
- II. Minimum rental period is one (1) day / 24 hrs., rental will start immediately soon after the Rental Agreement is signed.
- III. The company ensures that your rented vehicle is clean and in a road worthy condition. Vehicle must be returned in the same condition and time as rented. Any new minor or major damages / loss parts will be charge to the renters account accordingly.
- IV. Extension - for rental extensions, customers should inform KK and T / Fox Rent a Car /Economy at least a day before the rental due date for proper documentation and as to avoid unnecessary penalties.
- V. For Return - Vehicle/s should be returned on the agreed date and time, Failure to do so will result in late fee of one day after the 2 hour grace period has already passed.
- VI. Unsolicited and unauthorized replacement and alterations of vehicle parts is strictly prohibited and may/can cause corresponding fines / penalties.
- VII. Driving the vehicle more than its engines capacity (speed and weight limit) is prohibited.
- VIII. Driving the minicars , economy cars or any vehicles under 1.2 engines to rough roads, rugged, mountainous terrain, sandy and flooded area is strictly prohibited and if found, a corresponding minimum charge is \$150.00 but not exceeding \$250.00.
- IX. The company ensures that your rented vehicle is clean and in a road worthy condition. In return, the renter should take care of their rented vehicle and keep it on the same manner it was given to renters.
- X. Upon return, all new minor or major damages in the rented vehicle that is not reflected / shown in the checklist shall be billed / charged to the renter's account accordingly.
- XI. Please inspect your rented vehicle before returning it to and ensure you have not left any valuable items. KK and T / Fox rent a car is not responsible for any lost items inside the vehicle.
- XII. All Left / unclaimed items within 3 mos. are subject for disposal.
- XIII. Unauthorized Switching / Replacing vehicle parts without the management approval is strictly prohibited and may cause legal sanctions.

Reservations hold time

Holding Reservation: Vehicles will be held for two hours after the actual flight time. When exact flight details have been provided, we will honor all reservations for up to two hours after the reserve pickup time has passed. You may call or email us to advise of a change in your pickup time and we will honor your reservation. After the two hour window your reservation will be considered a no-show.

Refueling Charges: Vehicles must be returned with the same amount of fuel as rented to avoid a fuel charge of \$10.00 per gallon.

CDW

Collision Damage Waiver is a waiver of our right to collect from the renter for damage caused to the rental vehicle over the deductible amount. MCAR to CCAR \$15.95 per day for a deductible of \$1000.00 USD and ICAR to FXAR \$20.95 per day for a deductible of \$1500.00. C.D.W does not waive the right to collect for compressive loss or negligence such as driving the rented vehicle across beaches and lakes, or driving under the influence of liquor, drugs or any other substance that could impair the drivers ability to operate the vehicle. Other negligent acts include, but are not limited to, leaving the keys in the ignition with the rental vehicle unattended, falling asleep while driving, ignoring traffic signs or police officers, fire, vandalism, flood or any acts of God and driving on the wrong side of the road and keying the vehicle. : If a renter wishes to decline ALL or ANY coverage option and rely on their own insurance to cover the vehicle, the renter must provide proof from their insurance company or credit card company, specifically stating coverage is effective in the country of Turks and Caicos Islands, for the duration of the rental agreement for liability insurance a security deposit of 10% of the vehicles full value will be required. If proof is not verified or is invalid it will be necessary to purchase our insurance.

For accident involved vehicles, the Police will determine who is at fault; if the ruling will be in favor of the other party the renter must / should:

1. Settle all the damages incurred for both vehicles (rented car and 2nd party vehicle)
2. For Accident repair (renter's fault)- the renter is liable to pay the daily rental cost while the accident involved vehicle is under repair.

PRE-AUTHORIZATION: A credit card authorization equal to 10% of the vehicles full value (USD/700 to USD/3,500) can be secured at time of rental. This authorization amount may be used toward damages of vehicles or late charges.

Customer's accepting (CDW) credit card will only be authorized in the amount of \$500.00USD toward miscellaneous charges.

AIRPORT FEES: Free customer pickup and drop off

EXCESSIVELY SANDY/DIRTY RETURNS: A fee of \$ 150.00 will be charged to your credit card or deducted from any other deposit.

LOST KEYS: Will attract a minimum charge of \$ 150.00

LOCKSMITH FEES: Customer will be charged an added fee of \$ 150.00 for locksmith to unlock doors etc with keys left in the ignition.

SMOKEY RETURNS: will attract a fee of \$250.00 for the removal of the smoky smell.

UNAUTHORIZED DRIVERS: The rental contract and insurance is hereby void if the rental car is driven by anyone other than the renter or the additional authorized driver. A PENALTY FEE OF \$70.00 WILL BE CHARGED FOR ANY/ALL UNAUTHORIZED DRIVERS.

COLLISION & PLI DAMAGE: Does not include comprehensive loss or negligence such as driving the rented vehicle across beaches and lakes, or driving under the influence of liquor, drugs or any other substance that could impair the drivers ability to operate the vehicle. Other negligent acts include, but are not limited to, leaving the keys in the ignition with the rental vehicle unattended, falling asleep while driving, ignoring traffic signs or police officers, fire, vandalism, flood, hail or any acts of God and driving on the wrong side of the road (The right side) and keying the vehicle .

AUTHORIZED CREDIT CARD HOLDERS: The credit card holder must be the main driver and any additional drivers that want to be added to the contract must be on the credit card as well in order for the credit card insurance to apply in case of an accident.

TIRE POLICY: A spare tire and tools are provided inside of the vehicle. Also our glass and tire protection, will apply to all customers to accept the policy. Persons declining this policy will be charged the full cost of the tire, rim, labor and the roadside assistances.

FUEL CHARGE: Gas must be placed back into the vehicle upon return or a fee of \$ 10.00 per gallon will be charged to your credit card/pre-auth deposit.

ACCIDENT: All accidents must be immediately reported to the Police and to Economy Rent A Car or KKandT's Auto Rentals ltd office via telephone number 1-649-946-4624/941-8377.

VEHICLE RETURN: Vehicle must be returned in the same condition and time as rented. Failure to do so will result in late fee of one day after the 2 hour grace period has already passed.

Vehicle replacement -

- Replacing a vehicle should be informed at least 24 hrs prior to exchange and must be with a valid reason such as minor and major mechanical / electrical issues; the management will provide a temporary replacement vehicle that may not be the same car group but road worthy enough to use till a suitable replacement becomes available.
- In replacing a vehicle due to change of preference and other non mechanical issues will depend on the vehicle availability.
- For vehicle exchange/s outside the main office, our office will attend to every request however staff availability will have to be considered.

CANCELLATION - B

- I. Cancellation of rentals should be done 48 hrs prior to the actual booking; failure to do so, the renter will be required to settle 30% of the entire rental cost.
- II. Cancellation during / within the rental period - renter's who decided to return their vehicle earlier than the due date shall have to settle the entire rental costs stated in the Rental Agreement. The company is not liable for the renter's sudden change of schedule, as we at KK and T / Fox Rent a Car / Economy provides / allocates your vehicle request the minute you walked in or from the time you booked it on-line.
